SUBJECT: Obsolete Fire Arms/Property Surplus

PURPOSE

The purpose of this Resolution is to seek Council authorization to dispose of obsolete fire arms/property surplus.

BACKGROUND

The Orange City Police Department is in possession of certain firearms which have been removed from service and that have exceeded its useful life.

RECOMMENDATION

The City Council approve Resolution No. 514-08 thereby authorizing the City Manager to dispose of the obsolete fire arms/surplus listed in Exhibit A of this Resolution in a manner provided by law and remove same from the City's inventory of fixed assets.

RESOLUTION NO. 514-08

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, DECLARING CERTAIN FIREARMS AS PROPERTY SURPLUS; AUTHORIZING DISPOSAL OF THE PROPERTY; REPEALING ALL RESOLUTIONS IN CONFLICT HERewith AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Orange City Police Department is in possession of certain firearms (as described in Exhibit "A") which have exceeded their useful life; and

WHEREAS, it is the desire of the Police Department to dispose of said obsolete weapons.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:

SECTION 1. The property described on Exhibit "A" attached hereto and by reference incorporated herein is hereby declared to be surplus.

SECTION 2. The City Manager is hereby authorized to dispose of the property described in Section 1 above in a manner provided by law and to remove the surplus property from the City's inventory of fixed assets.

SECTION 3. That all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed.

SECTION 4. This Resolution shall become effective immediately upon its adoption.
