SUBJECT: **Appointment to Planning Commission**

PURPOSE

To appoint a replacement for Seat 6 on the Planning Commission.

BACKGROUND

Hector Gonzalez was Council Member Jim Mahoney's appointee to Seat #6 on the Planning Commission. The appointment was finalized for a term to commence December 11, 2007 and to end in December 2009. Unfortunately, due to unforeseen changes in Mr. Gonzalez' personal life he will be unable to fulfill his commitment on the Commission. Council Member Mahoney is nominating Bob Storke as Mr. Gonzalez' replacement to fill the unexpired portion of the term for Seat #6.

RECOMMENDATION

It is recommended that the City Council approve Resolution No. 477-08 to appoint Bob Storke to fill a vacancy in Seat #6 on the Orange City Planning Commission.

RESOLUTION NO. 477-08

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, APPOINTING ROBERT STORKE TO SEAT #06 ON THE ORANGE CITY PLANNING COMMISSION; REPEALING ALL RESOLUTIONS IN CONFLICT HERewith AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 3.01 of the Charter of the City of Orange City provides for the appointment of Boards and Committees by the City Council; and,

WHEREAS, Section 3.3 of the Orange City Land Development Code (LDC) provides for the establishment of the Planning Commission and a procedure for appointments thereto; and

WHEREAS, Hector Gonzalez, Council Member Mahoney's appointment to the Planning Commission, has found it necessary to resign his position on the Planning Commission; and,

WHEREAS, Council Member Mahoney wishes to appoint Robert Storke as Mr. Gonzalez' replacement for Seat #06 on the Planning Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:

SECTION 1. That Robert Storke is hereby appointed to the Planning Commission of the City of Orange City, Seat #06, to fill the unexpired term of Hector Gonzalez, said appointment to commence on April 8, 2008 and to expire on December 31, 2009.

SECTION 2. That the individual named above shall have all of the powers, duties and responsibilities as set forth in the Ordinances and Resolutions of the City of Orange City, and the laws of the State of Florida.

SECTION 3. That all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed.

SECTION 4. This Resolution shall become effective immediately upon its adoption.
