**SUBJECT:** **Appointment to River of Lakes Heritage Corridor Advisory Group**

### **PURPOSE**

To appoint Council Member Bill Crippen to serve as the City's representative on the River of Lakes Heritage Corridor Advisory Group.

### **BACKGROUND**

The City has been a member of the River of Lakes Heritage Corridor Advisory Group (CAG) since 2008. As part of that membership, the City is entitled to one directorship on the "Corridor Management Entity" (CME). Alan James has served in that capacity since the City first began its membership and no longer wishes to fulfill that commitment.

The authorizing legislation for the CAG recommends that it is preferable for local governments to appoint an elected official. Council Member Bill Crippen has agreed to serve as the City's Director on the CME.

Resolution No. 587-10 has been prepared to formalize the appointment of Council Member Crippen to the River of Lakes Heritage Corridor Advisory Committee – Corridor Management Entity.

**RESOLUTION NO. 587-10**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, FORMALIZING THE APPOINTMENT OF COUNCIL MEMBER BILL CRIPPEN TO THE RIVER OF LAKES HERITAGE CORRIDOR SCENIC HIGHWAY CORRIDOR ADVISORY GROUP; REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City Council of the City of Orange City voted unanimously on July 8, 2008 to participate in the River of Lakes Heritage Corridor Scenic Highway Corridor Advisory Group (CAG); and

**WHEREAS**, as part of the membership agreement, the City is entitled to one appointed representative to serve as a Director on the Corridor Management Entity (CME) for the CAG; and the City Council wishes to appoint Council Member Bill Crippen as its representative on the CME.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:**

**SECTION 1.** That Council Member Bill Crippen is hereby appointed to represent the City of Orange City on the River of Lakes Heritage Corridor Scenic Highway Corridor Management Entity.

**SECTION 2.** This appointment will be effective immediately and shall run until such time as a replacement is appointed by the City Council.

**SECTION 2.** That all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed.

**SECTION 3.** This Resolution shall become effective immediately upon its adoption.
