

1 **MINUTES OF THE SPECIAL MEETING** of the City Council of the City of Orange City, Florida, held
2 on Tuesday, November 15, 2011 at 6:00 p.m. in Council Chambers, 201 N. Holly Avenue, Orange City.

4 **CALL TO ORDER**

5
6 The meeting was called to order at 7:00 p.m. by Mayor Strickland and roll call was taken.
7

8 **ROLL CALL**

10 **PRESENT:** Mayor Harley Strickland; Vice Mayor O. William (Bill) Crippen; Council Members Jeff
11 Allebach, Tom Abraham, Tom Laputka, Anthony J. Pupello, Gary A. Blair; City Attorney Bill

14 Council Member Tom Abraham introduced Dana Karuvela, who performed a violin rendition of the Star
15 Spangled Banner and America the Beautiful.

- 17 **1. RESOLUTION NO. 659-11:** A resolution of the City Council of the City of
18 Orange City, Florida, pursuant to Section 4.12 of the City Charter, canvassing the
19 votes and declaring the results of the runoff election held in the City of Orange City
20 on November 8, 2011; repealing all resolutions in conflict herewith and providing for
21 an effective date.

23 Council Member Allebach read the title of Resolution No. 659-11 into the record.
24

25 **Council Member Laputka moved to approve Resolution No. 659-11,**
26 **seconded by Council Member Blair and passed by unanimous roll call vote**
27 **of the Council.**

- 29 **2. Outgoing Council Member's Remarks**
30

31 Mayor Strickland invited the outgoing Council Members to make their farewell comments.
32

33 **A. Council Member Jeff Allebach**
34

35 Council Member Allebach stated, "It's time, I had to come to retire." He recalled what prompted him to
36 become a council member. He said he attended a visioning session in the City in 1995 and was fortunate
37 to see several of the things that were "dreamed up" become a reality. Citing the development a
38 commercial area on Saxon Boulevard and development of a medical "hub" in the City, Council Member
39 Allebach stated "I am pretty proud of that." He talked about the problems and obstacles that Council has
40 overcome during his tenure. He stated that when the economy was better, Council consistently lowered
41 the millage rate to keep services affordable. City staffing has grown and now includes caring people who
42 work hard for the citizens. He recalled other council members that he has worked with over the years and
43 stated they truly "wanted to make a difference."

45 Addressing the newly elected officials, Council Member Allebach stated that there is still a lot to do. He
46 challenged the Council to "continue to help people feel a sense of community and pride." He stated,
47 "Make it so that people cannot bash government and remember that a Council that works together gets
48 things done." Council Member Allebach concluded by stating "The last nine years that I have been on

1 Council have been really, really good...I had a lot of good times, fun times. I am sad to go at this
2 moment, but I still live here and I'm proud of it. One last final plug, January 28th and 29th is the Manatee
3 Festival.”

4
5 Vice Mayor Crippen asked Mr. Allebach to step down from the dais. He presented him with a plaque for
6 his years of dedicated service as a Council Member for Orange City.

8 B. Mayor Harley Strickland

9
10 Mayor Strickland thanked Mr. Allebach for his help in reading the title of resolutions and ordinances into
11 the record. He said five years ago, he did not know he would be a mayor. He said his family had been
12 involved in Orange City politics for many years but that he is a social worker at heart and was raised to
13 help others. Politics is a hard life. Learning to be a mayor is also difficult because there are no road maps.
14 It took several years to learn the job and what a mayor needs to do on behalf of the citizens. Mayor
15 Strickland stated, “I am getting ready to close this chapter in my life and that leaves me feeling sad. It
16 also leaves me with a sense of relief and takes away a burden. I have always tried to represent our city
17 well. Some of that has worked well and some has not worked so well. My intentions have been good, but
18 not always perceived that way by others. We (*the City*) have gone through a period some people would
19 call a revolution. The number of changes that have occurred in the City government in last 4 years are
20 significant, changes that were needed and that prompted me to run for office. I hope that the next time
21 that changes are needed, other folks will step forward. I have learned that one of the prime motivations
22 for many politicians is that they get ticked off about something and decide they are going to run to do
23 something about it. Well, that's certainly what happened for me and I am proud of all that has happened
24 for my city and your city and our city.”

26 Mayor Strickland noted a plaque on the wall of the Council Chambers lists the Mayors of Orange City and
27 his name is now on it. He discussed the previous Mayors of the city. Mayor Strickland concluded by
28 stating, “The existence of this town has been amazing, we have had lots of people come and go.” The
29 Mayor continued stating, “The city has grown from a little bitty staff to a large staff providing a lot of
30 services.” He thanked the staff for all they do and suggested that everyone who sees City staff out and
31 about working to also thank them. Mayor Strickland stated, “The staff was putting up Christmas
32 decorations and I can't wait to see what that is going to look like. That would be wonderful. So again, it's
33 been a great ride, I've enjoyed it and I wish our city and all of you well.”

35 Vice Mayor Crippen presented Mr. Strickland with a plaque for his years of dedication and service as
36 Mayor of Orange City.
